What is the overall deductible?	Maximum Savings: Individual \$500 / Family \$1,250. Standard Savings: Individual \$1,000 / Family \$2,500. Out-of-Network: Individual \$2,125 / Family \$5,312.50.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes.
